Subject: Access to database for quantity notifications

Dear Sir or Madam,

As of April 2017, you can have a direct access to the quantities notified in the database (Extranet portal). Here you can see on a daily basis the quantities declared by the slaughterhouse or the coordinator, which were transferred to the clearing house **BFS finance GmbH**. In this way, you are able to check at any time, whether all entries are correct and, if necessary, arrange changes. Additionally, you can also view and download documents (such as delivery reports and quarterly credit notes) in the archive as PDF files.

Please note that you will have read-only rights. The notifications regarding the amount of animals/ kg live weight, as well as all corrections or posterior declarations, must continue to be carried out by the respective slaughterhouse or coordinator. TERMS OF USE for BOP

BFS finance GmbH, hereinafter referred to as BFS, is entitled to further develop the portal technically, legally and by adding new functions without the further consent of BOP users.



Contents for BOP participants (agricultural businesses)

Participants can access their movement data reported by the coordinator and abattoir. The documents prepared for participants can also be accessed and called up as PDF files.

User ID and password

Each participant can log in to his/her protected data area with the help of a personal user ID (accounts receivable number) and password. After sending the registration documentation to BFS, participants receive their user ID and password per e-mail once the documentation has been verified by BFS. To guarantee the greatest possible security, the password has to be changed immediately by the participant after logging in for the first time and every **two months** thereafter. A request to do so appears automatically when participants log into the system. A **free of charge access** will be provided to every participant. The simultaneously usage of one account by several people is prohibited. In the event of misuse, BFS refuses to accept a guarantee of any kind for the data transfer and their correctness.

Liability

- 1. Each participant is responsible for ensuring that the password relating to each user cannot be accessed by third parties. It must be kept secret. The user assumes full responsibility for all actions undertaken using his/her user name in combination with his/her password.
- 2. Participants are obliged to notify BFS without delay of every unauthorised utilisation of a user ID as soon as he/she becomes aware of this. In the event of unauthorised utilisation, the user must change his/her password immediately.
- 3. In the event of a change of the user of an Extranet portal access, the signatory of the registration form is obliged to ensure that the password is changed immediately. BFS will not accept any liability for damage caused culpably by the unauthorised or incorrect use of the password-protected log-in of a user.
- 4. In the event of an infringement of these terms of use, BFS reserves the right to refuse the user access to BOP.

Severability clause

Should any of the provisions of these terms of use be or become invalid in full or in part, this will not affect the validity of the remaining terms of use. This will apply in particular if the invalidity only relates to individual components. The invalid provision will be replaced by a provision whose content comes closest to fulfilling the intended economic purpose of the invalid provision in a legally effective manner.

Miscellaneous

Unless expressly amended in these terms of use, the other contractual agreements between the parties remain unaffected by them.

Place of jurisdiction

Provided that the party involved is entered as a merchant in the commercial register, the place of fulfilment and jurisdiction for all disputes arising from this agreement will be Gütersloh.
